- **Manually entered reference number** in temporary voucher was getting changed after voucher review. Fixed the behaviour so the **reference number remains the same after voucher review**.
- **Pending vouchers were not loading on pressing F5** in the Temporary Voucher Review screen. Now the issue has been resolved now.
- Issue in **Voucher/Master Approval** configure button hide after saving the configuration. Now Issue has been resolved.
- **Enter key issue in the configurable Profit & Loss / Balance Sheet**. The functionality is now working properly.
- **RTE-91** was occurring while enabling and saving features in the **Accounts feature**. This issue has been resolved.
- **Parameter details** are not printing when a previous year's sale challan is adjusted in the current financial year. Now issue has been resolved.
- While using Item group wise scheme in vouchers, sometimes quantity was not being updated in vouchers. Now problem rectified.
- An RTE-9 error was encountered while opening the Production Variance Report Summary-wise. Now problem rectified.
- RTE 3354 was occurring while opening the MSME Audit Info Report for the Sundry Creditors group. This issue has now been resolved.
- **In the Bill Receivable Report**, vouchers were getting displayed even when the **"Include Unapproved Entries" option was set to "N" while Auto Create Party Reference was enabled**. This issue has now been fixed.

Release 14.4 (22-04-2026)**Minor Changes**

- While creating a **new company**, sample cheque formats have been provided for banks such as **HDFC Bank, Bank of Baroda, Union Bank of India, State Bank of India, and Axis Bank**. This helps users quickly set up cheque printing without manual configuration.
- During **Party Master creation from GSTIN**, if the **Trade Name** is received as “N/A”, the system will now populate it using the **Legal Name** to ensure data accuracy.
- A provision has been made to enable **TDS configuration for Capital Accounts**. The **TDS window** will now appear during applicable voucher entries, along with support for **TDS reference creation**.
- Users can now **input interest details** for **late GSTR-3B filing** while viewing the return in **Form, JSON, or Plain Excel format**.
- A provision has been made to display a **validation error** when a **non-numeric HSN value** is entered during **Bulk Update HSN in Multiple Item Creation/Modification and Multiple Account Creation/Modification**.
- Minor changes have been made while creating new company regarding Default Financial year.

Bugs

- Voucher details for the **previous financial year** were not appearing while checking the **Query on Barcode** report. This issue has now been resolved. This issue has been arised from 14.0 onwards.
- While carrying **parameters with Sales Price** to the new financial year, the **Sales Prices** were not reflecting as per the previous year details in some cases. This issue has now been resolved.

Release 14.3 (03-04-2026)**Minor Changes**

- A new option in **Page Settings** allows the system to automatically use the same number of copies for the second format as defined for the first invoice during printing.

Bugs

- An issue was observed where duplicating an existing **Sale Type/Purchase Type** for **Pakistan** resulted in an error, while creating a new one worked correctly. This issue has now been resolved.
- While importing vouchers through **Excel**, the **TDS amount** applied on the **taxable amount** was not properly considered in the **TDS Reference window** when **TDS Bill Sundry** was used along with **CGST and SGST**. This behaviour has now been corrected.
- After changing the Financial Year (F.Y.), the default Tax Category configured in Masters is removed instead of being carried forward when an effective date (w.e.f.) is specified. However, the system behaves correctly for newly created Tax Categories. Now issue rectified.
- An error occurred during **bulk invoice upload to Google Drive** in **BUSY Online**. Now issue rectified.

Release 14.1 (22-02-2026)**Major Changes for Mobile App**

- Now, users can enable the **same voucher series** feature in Busy for posting vouchers in **Mobile App and BUSY Desktop**, ensuring consistent and uniform voucher numbering across platforms.
- Now User can create Purchase & Purchase return Vouchers in Mobile App.

Minor Changes

- The **“Refer & Earn”** feature has been introduced in the Busy Desktop, allowing users to initiate customer referrals directly after login. Users will earn referral credits upon successful activation of the referred customer.
- Minor changes have been implemented in the Change Softlock Email/Mobile process for smoother and more reliable operation.
- Now, users can **download a sample Excel sheet for importing Payment & Receipt Vouchers** as well. Earlier, this facility was available **only for Inventory Voucher imports**.
- Now, when the **F4 key** is used to pick items in POS and the **barcode-based item name** option is enabled, the system will show additional **item information** for better clarity and faster selection.
- Minor Changes in Sale without Order Report.
- A provision has been made to **include sales made against challans** while calculating the **Top 5 Items transactions** on the user dashboard. Earlier, only **direct sale invoices** were considered.
- A provision has been made to **record an entry in the Event Log whenever a user is deleted**, ensuring better audit tracking.
- Minor changes in Profitability reports.
- The **“Re-carry forward balances” prompt**, which was introduced in **version 13.8**, has now been **removed** as it was **time-consuming** while verifying balances from the previous financial year.
- Provision has been made to send WhatsApp messages using the **configured “BusySMS” format** instead of the default format while sharing through **Update Transport Details (Misc. Data Entry)**.
- A provision has been made to show item values in the Production Variance Report, enabling better variance analysis.
- A new provision has been introduced to show the value of items in the Horizontal Item Monthly Summary Report, providing better analysis.

Bugs

- While sharing WhatsApp messages through **Offline E-mail/SMS Utilities**, the message content was not displayed properly when the “**Send PDF Link for Invoice**” option was disabled. This issue has now been resolved.
- The **Payment QR Code** and **e-Invoice QR Code** were not printing in a single row on the invoice. This issue has now been resolved.
- In **Nepal**, the **IT PAN number** was not getting updated when the party was selected using **F4** under **Billing/Shipping Details**. This issue has now been resolved.
- The message “**PDC Date is out of range in Current F.Y**” appeared while selecting a voucher under **PDC Details → Miscellaneous Data Entry** when the system date format was other than **DD/MM/YYYY**. This issue has now been resolved.
- In a few cases, **RTE-6** occurred while viewing **On-Enter Details** of an item after loading the **Stock Status → Balances Only** report with the **Show Zero Stock Items** option enabled. This issue has now been resolved.
- **RTE-438** was generated while reconciling a voucher in the **Account Ledger** when the ledger was accessed by drilling down from the **Balance Sheet**. This issue has now been resolved.
- In the **BCN-wise Profitability Report**, when generated for a **specific date range**, the **Qty. Out** and **Amount Out** were incorrectly shown for the **entire financial year** instead of the selected period. This issue has now been resolved.
- **RTE-3354** was generated while checking the **Profitability Report (Item-wise)** when “**Item to be shown by**” was set to **Alias** and some items did not have an alias defined. This issue has now been resolved.
- An **RTE-13** error was generated when an invalid **time range** was entered in the **Scheme Configuration**. The issue has now been fixed.
- The “**Restrict Back Date Entries**” configuration was not being saved under **User Configuration** when no voucher series was specified. This issue has now been resolved.
- **RTE-3407 (Record is too large)** occurred in the **Audit Trail** when a voucher was modified multiple times (more than 15 times). This issue has now been resolved.
- In **Query on Transaction**, when a voucher was selected from the **second row onwards**, a **blank Receipt** opened instead of the selected voucher. This issue has now been resolved.
- In the **Sales Analysis** report, the **Average Price** was not calculated correctly when any row was hidden using the **F9** key. This issue has now been resolved.
- In the **Standard Invoice** configuration for **Saudi Arabia**, the caption “**Print E-invoice QR Code**” overlaps with another option. Now rectified.
- Minor issues have been rectified in *Day end Report(Summary & Detailed)*.
- In some cases, **RTE-9** was generated while importing Excel for **Auto Bank Reconciliation** when the number of records exceeded **1000 in Excel**. This issue has now been resolved.

Bugs

- In **BUSY Online**, users were unable to save the image/Logo in the **Standard Invoice Printing configuration**. This issue was occurred in **version 13.8** and has now been resolved.

- In the **Standard Invoice** configuration for **Saudi Arabia**, the caption **"Print E-invoice QR Code"** overlaps with another option. Now rectified.

Release 13.8 (31-12-2025)

Major Changes

- From now on, the following features will be available **only when BLS is active**
 - Printing of Customized Invoice Formats
 - Add/Modify Formats, Custom Columns
 - Customization, Custom Reports, User Activity Log, SQL Query
 - Switching of Users
 - Import/Export for Masters and Vouchers
 - Bulk Updation Menu
 - Bank Reconciliation Report
 - Salesman/Broker-wise Reporting

This linkage ensures controlled access to advanced features based on BLS status.

Minor Changes

- Earlier, even sub-users without any **Housekeeping rights** were shown the **Housekeeping process required** warning at company login. Now, this warning will appear **only for the main user or sub-users who have Housekeeping permissions**.
- The following countries have been added to the country list: **Togo, Georgia, and Kazakhstan**.
- A provision has been made to **restrict the selection of Bill Sundries** other than **'Round Off' nature** in **Voucher Series Configuration** when the **"Auto Round-Off Final Amount"** feature is enabled. This ensures accurate rounding and prevents incorrect sundry selection.
- While printing barcodes (Add-On) from vouchers, the voucher list was earlier displayed based on the **voucher date**. Now, the list will be shown as per the **stock updation date used in the voucher**, similar to the listing of **purchase vouchers**.
- Now, a **warning message** will pop up if **Microsoft Excel is not installed** on the system while using **Excel-related features**. This helps users understand why the feature cannot be executed.
- Earlier, there was no provision to update **Voucher Optional Fields** from **Miscellaneous Data Entry** for **Sales Orders, Purchase Orders, Sales Quotations, and Purchase Quotations**. Now, this provision has been added.

Bugs

- The field **"Original Sale/Purchase Date"** in the Sales Return Register (Columnar format) and other reports was not working correctly when the system date format was set to **DD-MMM-YYYY**. This issue has now been resolved.

- While using the *Tax Inclusive Price* feature in the Item Master along with the *Item Quantity-wise Discount* structure, the price was being picked incorrectly at the time of voucher entry. Now problem rectified.
- The captions for *Supply Inward* and *Supply Outward* were not displayed correctly when the option “**Show captions of Sale/Purchase vouchers as Supply Outward / Supply Inward**” was enabled from GST/VAT configuration. This issue has now been resolved.
- **RTE-380** was occurring while adjusting the **BOM in Production / Unassemble vouchers** when the number of items entered exceeded the configured maximum item entries. This issue has now been resolved.
- The user signature image was slightly misaligned and shifted outside the signature box when vouchers were printed with the **Payment QR Code**. This problem started from **13.7** and has now been corrected.
- Special characters were not allowed while saving the **Company Short Name** in *Modify Company*. However, during **WhatsApp** or **BNS** sending, the system prompted for the short name (if not already defined) and incorrectly allowed saving special characters. This issue has now been fixed.
- In a few cases, an RTE occurred while generating the **Sales Analysis** report for **One Party Group** when the **Show GST Amount** option was enabled. This issue has now been resolved.
- When the option “**Show Voucher Long Narration in Report**” was enabled, **RTE-457** occurred while opening **Multi-Company Results → Bill Receivable → Group of Accounts → Bill-Wise (Combined)**. This issue has now been resolved.
- While creating company in the **Nepali Region**, the **User Activity Log** was displaying all entries with the same date, although the details appeared correctly when a specific date was selected. This issue has now been resolved.
- Users were prompted with the “**Re-carry forward balances**” message while logging into the company, despite having already completed the carry-forward process. This has now been fixed.
- In the **Single Column Cash/Bank Book** report, the **Opening Balance** was not displayed correctly when the **PDC Voucher** option was enabled and the report was viewed for a selected date range. This issue has now been resolved.

Release 13.7 (08-12-2025)**Major Changes**

- A new provision allows users to generate Balance Sheet and Profit & Loss Account in Schedule III or Non-Corporate format. Users can conveniently tag accounts or groups using the F4 key to customize classification.

Minor Changes

- A new Issue/Receipt Analysis report (Detailed & Summary) has been introduced under Bardana/Crate Management to help users easily track and analyse the movement and balance of Bardana/crates.
- Now, users can create **multiple voucher series for Mandi** under a single voucher type. Earlier, only the **predefined voucher series** could be used. This enhancement provides greater flexibility and customization in voucher management.
- In the **Mandi Add-On**, a new report titled '**M Form**' has been provided. This report helps users easily track and manage **mandi-related transactions** in a structured format.
- A provision has been made to display a clear and informative error message when data(GSTR-2A & Invoice Data from IMS) cannot be fetched from the GST portal due to high invoice volume. Earlier, the system showed a blank message, causing confusion for users.
- Now, a provision has been made to display Sale Price details in the Batch-wise Closing Stock Details Report, similar to how MRP is shown. This gives users a clearer view of both selling price and MRP
- Agent wise Receivable report has been optimised.
- Now, when a user changes the Currency Decimal Places, a warning message will appear on the configuration page: "*Changing Currency Decimal Places may cause mismatches in reports. Do you still want to continue?*" This ensures users are aware of possible report discrepancies.
- Now, if the invoice logo name or logo path is changed, the system will display a warning message while saving the invoice format. This helps avoid unintentional changes to logo settings.
- While configuring auto-generation of Print Name, an incorrect warning message—'Total length of print cannot be greater than 40'—was appearing. The limit has now been increased to 60,
- A new provision has been made to display the alias of the Bill of Materials (BOM) in the list for easier identification.
- Now, a provision has been made to display a "Cancelled" image while printing cancelled vouchers. This helps users easily identify cancelled documents in printed copies.

- Now, Item Descriptions entered in BUSY while creating vouchers will also be synced with the Mobile App. This ensures consistent item information across both platforms.
- A provision has been made to allow updating the **Pincode** in **Transport Details** during voucher entry. Earlier, the Pincode did not update unless the **E-Way Bill** feature was enabled.
- A new report has been introduced to help users identify items where tax rates have been changed in Tax Category master. This report provides a clear view of all affected items, enabling users to track and verify tax rate changes for better compliance and accuracy in reporting.
- A new provision has been made to print a QR Code for receiving payments via UPI ID in Account Ledger and Invoice Printing. This simplifies digital payment collection and can be configured from Features & Options → General Tab.
- A warning message will now be displayed at the time of company login if any modifications or changes have been made in the previous financial year, prompting the user to update the financial year along with the new or updated master data.
- In the Softlock email/mobile change process, if a user mistakenly enters a serial number or numeric value instead of a valid email address, the system previously allowed the update without any warning. Now, a validation has been implemented to restrict invalid entries and ensure that only valid email formats are accepted.
- A new provision has been added to display critical level warnings at the parameter level. Earlier, the system only showed warnings based on the critical level defined for items. This enhancement ensures more accurate and parameter-specific stock monitoring.
- Minor changes in Bulk voucher creation for Receipt utility.
- If Alternate Units are enabled and Quantity Decimal Places are set to 0, a warning message will now appear recommending users to set at least 2 decimal places for accurate calculations and proper unit conversions.
- Earlier, BUSY allowed users to enter values exceeding six digits (including decimals) in account master for specifying Depreciation Rate, which caused the value to appear as asterisks (*) on the screen. Now, a restriction has been applied to prevent entry of excessively large values, ensuring clear and accurate data display.
- Now a provision has been made so that while sending messages to WhatsApp, the system will pick the WhatsApp number instead of the mobile number, ensuring correct message delivery.
- Now, Scheme Master items will pick tax rates automatically from the Tax Category Master, based on the effective date of tax changes, ensuring accurate tax calculation for free or promotional items.
- Previously, when opening a company, if GSPs were not configured, the system displayed a message and redirected the user to the GST/VAT Configuration page. Now, this process has been improved — on pressing 'Yes', the system will directly open the GSP Configuration form, making the setup faster and more intuitive.
- Minor changes in Sales analysis report for Parameterized details.

- The system now displays a warning alert while saving a voucher if all included item masters are marked with “Skip in GST” during E-way Bill or E-invoice generation, helping ensure GST compliance.
- A warning alert will be displayed during voucher saving if the “Skip in GST” option is enabled for all item master used in the voucher.
- Performance has been optimized for voucher opening in LAN Mode, resulting in faster loading and smoother operation during multi-user access.
- An Option has been provided in to download and view TDS/TCS details from the GST portal.

Bugs

- In a few cases, an RTE occurred while creating parties through the utility during bulk creation of inventory vouchers. This issue has now been fixed.
- While configuring the Columnar Register, the caption for the field ‘Qty_Grand_Total (Main)’ was not being displayed fully. This issue has now been fixed
- In BUSY Online, an issue where the E-Invoice QR code appeared only on some copies while printing multiple pages. The QR code will now be displayed correctly on all printed copies of the Invoice.
- In the Ageing Receivables (FIFO Basis) report, the branch-wise filter was not working correctly when the report was generated for a single party. This issue has now been fixed.
- Payment vouchers with tag "Against Reverse Charge Invoice" were not visible while checking the list of Payment vouchers. Now issue has been rectified.
- An RTE-3146 error was encountered when generating the Sales Analysis report with “Sales Only” or “Sales Return Only” options and the “Exclude Stock Transfer Sale Type Entries” setting enabled. The issue occurred specifically in the Client-Server edition. Now problem rectified.
- When the user tries to print Bank accounts through *Printing* → *Account Ledger* → *Selected Group* for a Bank/Cash Account, the output is coming blank. This issue has now been fixed.
- While importing vouchers from Excel, an RTE occurred if more than 999 rows were specified for a single voucher. Now, in such cases, a warning message will be displayed.
- In the current version, no warning message appears when a voucher is created with a duplicate serial number. This functionality was working correctly in BUSY 21 Release 13.0. Now problem rectified.
- RTE-5 error was generated when pressing “OK” on the “Invalid Sheet Number” message while importing vouchers from an Excel sheet. This issue has now been fixed.
- In a few cases, RTE-3146 occurred while running *Query on Transactions*, and this issue was found only in the Client-Server edition. The problem has now been fixed.
- RTE-91 occurred while adding a Mandi transaction when the Free Quantity feature was enabled. This issue has now been fixed.

- In a few cases, while adjusting challans in the Sales Voucher, the system displayed the error message “All items have not been fully adjusted against the challan,” even when the option "*Consolidate Items while Picking from Challans*" in Features/Options was enabled. This issue has now been fixed.
- The user was unable to attach multiple external files using a semicolon while sending an email. This issue has now been fixed.
- While checking the Balance Sheet, the Assets and Liabilities were showing a mismatch whenever the Book Commencing Date was different from the Financial Year Start Date. This issue has now been resolved.
- RTE-91 was being generated when clicking on a Custom Column in the Account Ledger Columnar Report. This issue has now been fixed.
- In Print Utilities, when a branch user printed invoices with the “All Series” option, the system incorrectly included other voucher series not mapped to that user. The problem has been resolved.
- Sales/Purchase Quotation vouchers could not be saved when the option “*Hide Alternative Unit Details in Voucher*” was enabled. Now problem rectified.
- When branch users printed an accounting voucher, the footer incorrectly displayed the company name. Now it has been resolved.
- A new validation has been introduced in the **Change Email/Mobile** form to ensure that mobile numbers entered for Indian users must be exactly **10 digits**. Previously, no validation was applied, which could lead to incorrect or incomplete entries.
- The “**Include Unapproved (Unposted) Entries**” option in the Ageing Receivable/Payable report is not working. The report shows the same output whether the option is enabled or disabled. Now issue has been resolved.
- When printing the Balance Sheet with the ‘Schedules for Fixed Assets’ option, the initial preview showed the correct portrait layout; however, viewing the preview again displayed it in landscape mode. This issue has now been resolved.
- In the *Parameter-wise Critical Level (Minimum/Maximum/Reorder)* report with **Consolidated MC**, the **Closing Stock** was appearing incorrectly because Sales and Purchase Orders were also being included in the calculation. This issue has now been resolved.
- RTE-91 was occurring while printing the barcode for a cancelled Stock Journal voucher. The issue has now been resolved.

- On a few operating systems, while copying masters from another company, the alignment of certain controls was not proper. This issue has now been fixed.
- Vouchers were not being generated from Opening Challan references through the utility if those references were carried forward from the previous year and the financial year was split. This issue has now been resolved.
- In a few scenarios, the MSME Audit Information report was not displaying the data correctly. This issue has now been fixed.
- While updating transport details under Miscellaneous Data Entry, not all voucher series options were appearing. This issue has been occurring since version 13.2 and has now been resolved.

- While configuring cheque printing settings, if the user specified the margin as 0, the program was not saving the value. This issue has now been fixed.

- In few cases, while opening BUSY a RTE 380 occurred. This issue occurred on Windows 7. Now problem rectified.

- Previously, BUSYOnline users were not allowed to create backups on Google Drive. With this update, users can now generate backups at their convenience and securely store them on Google Drive, with controlled limits on the number of backups maintained.

 - A modern and clean interface has been introduced for License Activation, delivering a more intuitive user experience.
 - Easy Flow
 - The activation process has been simplified with minimal clicks, making it faster and more user-friendly.
 - OTP Authentication
 - For License Activation, password-based authentication has been replaced with OTP-based authentication, ensuring improved security and convenience.
 - Auto Download of License File
 - Users no longer need to check their email, download, and save the license file in the BusyWin folder. BUSY now handles these activities automatically in the background, streamlining the activation process.

Minor Changes

- **Enhanced Validations for Item and Account Master for GST**
 - HSN/SAC codes must be numeric (2–8 digits).
 - Special characters or alphanumeric values are not allowed.
 - Validation of HSN will now always be done from the API during addition and modification of item master.
 - HSN Codes starting from 99 is mapped to tax categories which is tagged under Services and vice-versa too. This ensures proper categorization and compliance.
 - While saving Item Master, a warning will now be displayed if the UQC field is found blank in unit master, which is used in that Item. This prevents incomplete item creation.
 - **Additional validations introduced in Account master**
 - PIN Code must always be 6 digits, with no alphabets or special characters allowed.
 - Station/Location (if e-invoice is enabled) must have a minimum of 3 characters and cannot be blank.
- Previously, while preparing GSTR-1 e-return, users needed to run separate checks for Transactions, HSN Summary, and Document Summary errors. With the new enhancement, the system will automatically validate all these in a single step before e-return generation including validation of HSN Codes used during

the period.

- While validating HSN Online for multiple HSN, a filter for HSN Status (All, Valid, Invalid) has been provided. Invalid entries are shown in red, helping users easily segregate and review valid and invalid HSN codes.
- Profit & Loss report has been optimized.
- In recent updates, the **Data Directory** label was not shown while selecting a company from the list of companies. As per user feedback, it has been reintroduced to make the selection process clearer.
- In the Parameterized Stock Details window, when all parameters were enabled, the complete details were not visible. Vertical and horizontal scroll bars have been added, allowing users to view all parameter details with ease.
- On some machines, in the Query on Item Price report, when the Multiple Price List option was enabled, values under columns like Price (Dozen), Disc., and MRP were not fully visible. This issue has been fixed to ensure all values are displayed clearly without clipping.
- A branch-wise filter has been introduced in the Daily Summary and Daily Balance reports under Account Summary and Inventory Summary Section.
- Minor changes in utility 'Check Incomplete vouchers.
- To make user management easier, the *Superuser* will now be displayed at the top of the user list, ensuring quick visibility.
- New Country 'Benin' has been added in country list while creating company.
- New Country 'New Zeland' has been added in country list while creating company.
- The character limit for RTGS/NEFT reference details in payemnt/receipt voucher has now increased to 25 characters.
- While exchanging data via BDEP, cancelled vouchers will now be automatically excluded from the transfer, ensuring cleaner and more accurate data synchronization.
- While creating a new company by copying an existing company's setup, the e-invoice/e-Way Bill settings and GSP login credentials from the old company were also being copied. This has been corrected so that GSP credentials remain blank for the new company, ensuring security and proper setup.
- New field ITEM_MAST_MIN_SALE_PRICE has been introduced in Item Barcode Printing.
- While approving masters/vouchers from the Miscellaneous Data Entry section, the user name was not captured in the Detailed Audit Trail report. Now, a provision has been made to record and display the user name for better accountability.
- Label "Allow duplicates of BCN (within the same item and parameter combination)" in Parameter Configuration has been changed for better clarity.
- Inventory Monthly Summary now displays items with the 'Do Not Maintain Stock Balance' flag, showing a zero value in the column of 'Balance Quantity'.

- Now, the system will show a warning message in the Monthly ITC Tagging Report if any status is tagged before the invoice date. This helps users avoid mistakes during tagging.
- While uploading vouchers to **BDEP**, if the Target BDEP ID is invalid or blank in the Party Master, the warning message will display: **"Target BDEP ID is not valid for the party – "**. This ensures users can quickly identify the affected party.

Bugs

- In a few cases, from version 13.2 onwards, after printing an invoice, an extra blank page was also getting printed. This issue has now been fixed.
- In few cases, list of batches was not opening properly at the time of adjustment. Now issue rectified.
- In some cases, the alignment of 'Total B/d' on the second page of the Payment Register was incorrect while printing. The issue has now been resolved.
- While checking the account ledger for multiple financial years, if the user changed the date range using the F2 key and hid some rows using the F9 key, the closing balance was not updating properly. This problem occurred only when the 'Long Narration' option was enabled. Now problem has been resolved.
- If rows were hidden using F9 in ledger reports, the exported Closing Balance in Excel/PDF did not match the on-screen balance. Now problem rectified.

 - Market Fee Report – Summary & Detailed
 - Stock Not Delivered Report
 - Adhatiya (Vendor) Stock Report

Minor Changes

- In specific operating systems, while sending any invoice/report to WhatsApp, default focus is being set to "Quit" instead of "Send". Now behaviour has been changed.

Bugs

For each action, the system will display the status (e.g., Success or Failure)—allowing users to monitor compliance activities without separately logging in to the GST portal.
- Changes in Mobile App
 - To streamline return handling, the Sales Return voucher has been added to the Mobile App. User can control access through the Mobile App rights configuration.
- Enhancements in the Company Selection Interface
 - The 'Search Company' caption has been removed for a cleaner, more modern layout.

Release 4.1 (30-09-2021)**Minor Changes**

- Starting from this version, Excise/Service Tax features will no longer be supported in BUSY21. Users who want to check old Excise/Service Tax data can use BUSY18.
- Starting from 1st Oct, businesses dealing in food/consumable products are required to print their *FSSAI No.* and Party's *FSSAI No.* on invoice. To take care of it, provision made to specify *FSSAI No.* in Company and Party master and printing of same in Invoice/Receipt. Can be enabled in **Configuration→Features/Options/Inventory** tab. If *FSSAI No.* has been specified, it will be printed in standard Invoice/Receipt.
- Provision made for Report Notes at voucher level in Account/Inventory Registers.
- Sending bulk email through utility; while picking email id using F4 key, provision made to either append or overwrite the existing email id. Till now existing email id was always being overwritten.
- Data sync from HO to BO, till now un-approved masters and vouchers were getting synced to BO. Now unapproved entries will not be synced.
- Validating GSTIN, in case of some error from backend server, 'NA' was being shown in all fields. Now proper error message will be shown.
- Feeding 'B2B Expense'; if registration type of Party was 'Composition Dealer' no warning was being shown creating confusion later on. Now in such cases, a warning will be shown during data entry.

- Provision made to change Item's Main Unit after feeding transactions (conditional). While modifying an Item, a button has been provided to change Item's Main Unit. On clicking this button program will check the possibility of unit change and if possible will allow the same. Conditions for unit change are as below:
 - a. Only SuperUser can change Main Unit.
 - b. Alt. Unit and Packing Unit should not be specified for the Item.
 - c. No transaction in any other Unit should be fed.
- Creating new Party, provision made to create by specifying GSTIN and rest of the details being picked online from GST portal. Can be done by using F4 key while creating new Party.
- TDS configuration in Account master, till now it was not possible to enable both types of TDS (Expense & Gross Payment) for a Party. Now both can be enabled in Party master but only one type of TDS can be used in a single voucher.

- Invoice designing, new field <TOTAL_AMOUNT_WITH_DEEMED_TAX> provided which will print taxable value + deemed tax value for that invoice.
- Item Serial No. Stock Status & Ageing report, provision made to filter on a Branch.
- Stock Ledger, till now Daily Balance was being shown. Now option provided to show either Daily Balance or Running Balance.
- Ageing Analysis report, provision made to include Un-approved vouchers also.

 - f. Bill Sundry *Nature*, new option 'TCS' provided. To be used to check if TCS has been applied or not.
 - g. Single entry Payment/Receipt voucher; on selecting any Party, Gross Sales & Receipt was not being shown along with current balance. Now it will be shown.
 - h. TCS reference management provided in Sales Return vouchers also.
 - i. Gross Sales/Receipt was not being shown in Receipt voucher if entry was done through SubLedger. Now it will be shown.
 - j. While selecting any Party, time was being taken to check the gross Sales and Receipt along with current balance. Now speed improved.
 - k. New report 'Check Receipts eligible for TCS' provided to check Gross Receipts & applicability of TCS on Receipt vouchers for a period. User can also create a consolidated TCS voucher from there only using F4 key. Useful when user wants to charge monthly TCS instead of charging transaction-wise.
 - l. New report 'Reconcile Accounts & TCS' provided to check the discrepancy between TCS ledgers and TCS references.

- While creating new company, two new TDS Categories will be created for section 194-JA & 194-JB.
- *Minimum Sales Price* as specified in Item master was sometimes being treated as *Tax Inclusive* and sometimes as *Tax Exclusive* depending upon which Sales Type was being used. Now in all conditions MSP as specified in Item master will be treated as *Tax Exclusive* for comparison purposes.
- Voucher Replication on 'Call Receipt' voucher; no voucher was being replicated. Actually replication for 'Call Receipt' was not available. Now 'Call Receipt' has been removed from list of vouchers.
